7.1. Precautions for safe handling

Prevention of fire and explosion Take precautionary measures against static discharges: Ground/bond containers, tanks and transfer/receiving equipment.

Hygiene measures Ensure the application of strict rules of hygiene by the personnel exposed to the risk of contact with the product. Regular cleaning of equipment, work area and clothing is recommended. Wash hands before breaks and immediately after handling the product. Do not use abrasives, solvents or fuels.
