### 6.1. Personal precautions, protective equipment and emergency procedures

**General Information**

Do not touch or walk through spilled material. Contaminated surfaces will be extremely slippery. Use personal protective equipment. Ensure adequate ventilation. Remove all sources of ignition.

**Methods for cleaning up**

## 7. HANDLING AND STORAGE

### 7.1. Precautions for safe handling

**Advice on safe handling**

When using, do not eat, drink or smoke. For personal protection see section 8. Use only in well-ventilated areas. Do not breathe vapors or spray mist. Avoid contact with skin, eyes and clothing.

**Prevention of fire and explosion**

Take precautionary measures against static discharges. Ground/bond containers, tanks and transfer/receiving equipment. Design equipment to avoid accidental product leakage (for example due to seal failure) onto hot casings or electrical contacts.
